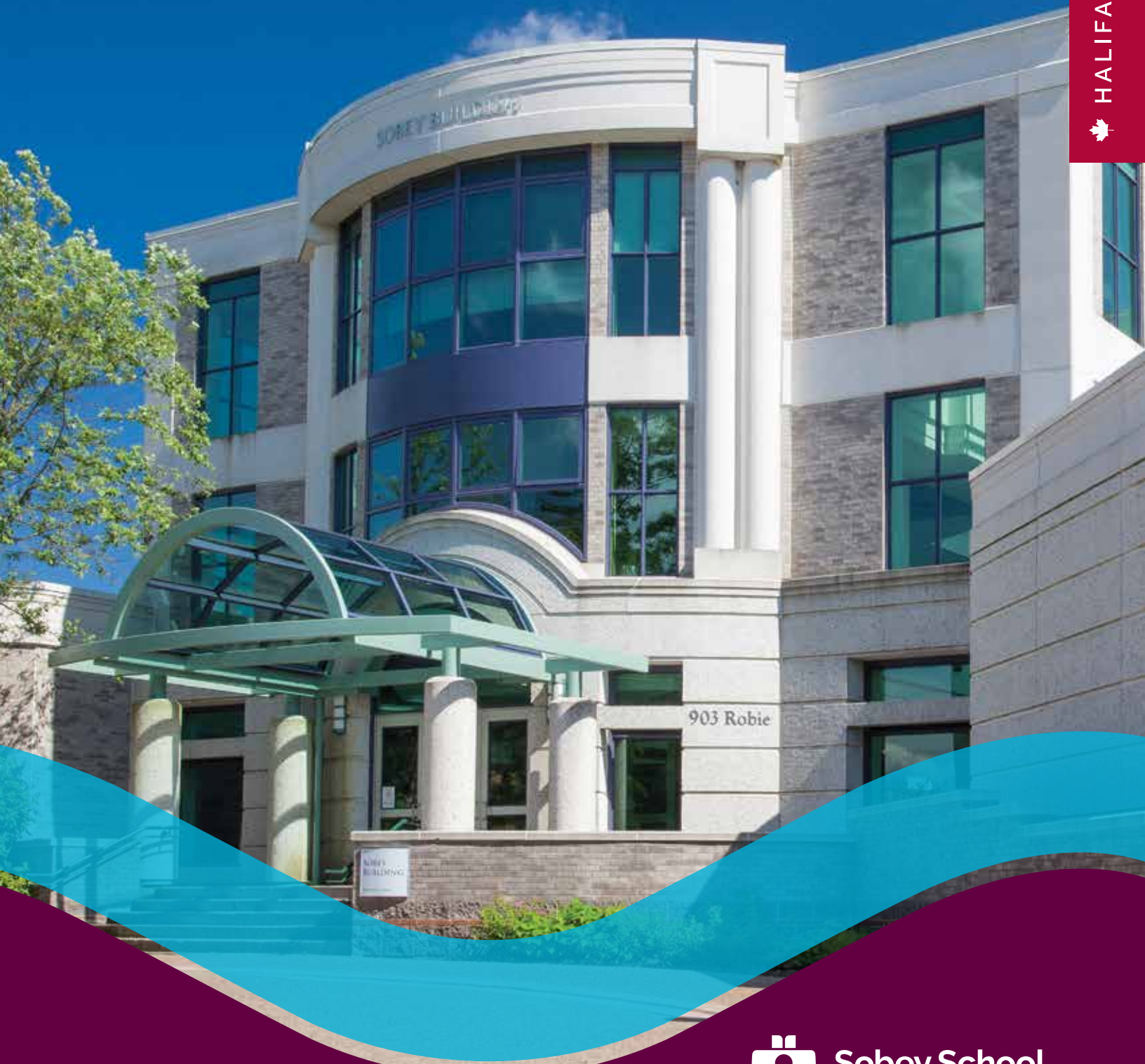

The Sobey School of Business Master of Finance (MFin) program is one of the oldest MFin Programs in Canada (since 2003) and one of the largest graduate programs at Saint Mary's University. It is a challenging, demanding and rigorous 12-month program in which you will gain the strategic financial skills that global employers demand. The Sobey MFin effectively prepares graduates for professional careers in financial analysis and advising, portfolio and risk management and corporate finance. Gain the insight needed to excel, and the global perspective, broad knowledge and honed skills to succeed as a leading financial professional. The Sobey MFin program is a crucial step in your future success.

- Complete your degree in just 12 months and get a head start on your career.
- Faculty include world-renowned scholars and academics including a university President Emeritus and a Canada Research Chair. Over 90% of MFin courses are taught by faculty with doctoral degrees.
- Launch or advance your career in the financial industry, corporate world or public sector organizations.
- Prepare for your Chartered Financial Analyst (CFA)[®] exams. The fee to enroll in writing 1 CFA Exam (Level 1 or higher) is included in your tuition.

Admissions

Admission requirements

- An undergraduate degree in mathematics, accounting, finance, engineering, computer science, economics or other quantitative discipline from a recognized university with at least a B average (3.0 GPA) or equivalent.
- If your first language is not English, you must submit an official TOEFL iBT® or IELTS. Tests cannot be more than two years old.
- We require an overall IELTS score of 6.5 with no band below 6.0.
- If your IELTS score is 6.0 with no band below 5.5, the university recommends a private language school that delivers Pre-MFin language training. There is an additional charge for this extra training.
- You must provide a current CV and supplementary documents including references.
- You must be available for an in-person or virtual interview.

Award details

- Canadian Citizens or Permanent Residents are offered a \$4,000 entrance award.
- Applicants who have successfully passed at least one CFA exam are offered a \$4,000 entrance award.
- A limited number of merit scholarships are offered to select students with the highest GPA in the program at the end of first two modules.
- A limited number of need-based bursaries are offered during the program.

Studying in Canada

As an international student, you may be required to obtain a study permit issued by the Canadian government's Immigration, Refugees and Citizenship Canada (IRCC) department prior to beginning your studies. You may apply once you receive your official letter of acceptance from Saint Mary's University. We recommend applying early for your permit as processing times can vary.

Studying in Canada as an international student offers numerous potential benefits, including the opportunity to work while studying, obtaining a post-graduate work permit, and exploring immigration programs and pathways. Students are granted these allowances through IRCC, and more information can be found at canada.ca/studyincanada. 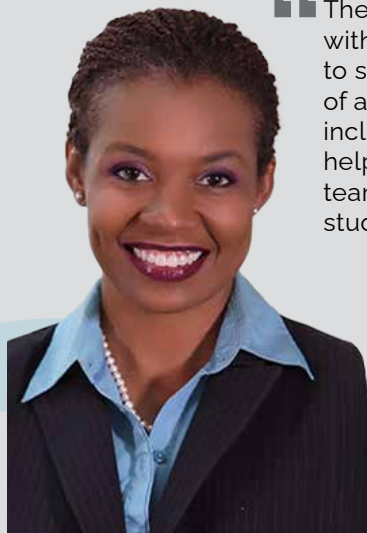
