Admissions of Permanent Residents (PRs) in Canada and Atlantic Canada

Annual trends

Since the turn of current century, PR admissions to Canada rose steadily from 250,590 in 2001 to 341,175 in 2019 (a rise of about 36.4%). The COVID-19 outbreak caused a sudden decline in 2020 due to the closure of visa offices overseas. After that, there has been a steep rise annually. In 2023, there were 471,810 admissions – about 88 percent higher than in 2001 (Chart 1).




Chart 1: Annual Admissions of Permanent Residents, Canada

Atlantic Canada exhibited similar trend over the period (Chart 2). Between 2001 and 2019, the region saw a six-fold increase in PR admissions (those declaring an Atlantic province as intended destination) and when immigration picked up from 2021, its 2023 admission was about 11 times higher than it was in 2001. This rise of inflows over the entire period is largely attributed to the deliberate attempts for attracting immigrants undertaken by federal, provincial, and municipal

governments as well as by community organizations. Immigration has now become a key source of population growth in the region. Without immigration, the region's population growth would have been negative.




Chart 2: Admissions of Permanent Residents, Atlantic Canada.

Where do PRs come from?

Immigrants who are granted PR status in Canada belong to diverse source countries. However, in 2021, half of them were admitted from five source countries and in the first quarter of 2024, their top five source countries comprised more than half of total arrivals. There are significant changes in the rankings and composition of top five source countries. While China occupied the top place in 2001 with 16% PRs being admitted from there, it was superseded by India in 2023 and in the first quarter of 2024 when the admissions from India exceeded 30% of total. Although UK (and its overseas territories) and the US both entered the top five source

countries' list in 2011, their composition in total admissions was a trickle, 1.3% and 0.4%, respectively. US was also on the list in 2021 and up from its 5th position in 2011 to 4th, but did not make the list since. In summary, immigration in Canada is becoming more concentrated in top five source countries dominated by India, followed by China. (Table 1).

PR admissions are also concentrated in top five source countries in Atlantic Canada although their composition is slightly different from that observed nationally. India remains the top source country since 2021. China occupied the third place in 2021 and 2023 but fell to 4th in the first quarter of 2024 when Afghanistan appeared on the list. Philippines remained the second largest source from 2021, rising from its 4th position in 2011 (Table 2). Some of the source countries that are represented in top five list of the region do not make to the list nationally (for example, Syria, Jordan, Morocco, Bhutan, Brazil, and Cameroon). This could mean that information regarding the regional attempts to attract immigrants is widespread around the world.

Source country composition of PRs varies across Atlantic provinces. India now occupies the first place in Nova Scotia, New Brunswick and Prince Edward Island but not in Newfoundland and Labrador where it is next to Philippines in the second place. (Tables 3-7).
